Professors

Estelle Cantillon, Université Libre de Bruxelles

Estelle Cantillon holds a PhD in Economics from Harvard University. She is FNRS Research Director at the Université Libre de Bruxelles. She is also an associated researcher at the Toulouse School of Economics. Cantillon currently serves as the Joint Managing Editor at the Economic Journal and is an associate editor at the RAND Journal of Economics. She also holds appointments as a member of WZB Berlin's Advisory Board, research fellow at the Centre for Economic Policy Research, and committee member of Rethinking Belgium, "Matching in Practice" research network, and the European Economic Association. She has previously taught at Harvard Business School, Harvard Kennedy School, and Yale University. Her professional interests are microeconomics, market design, industrial organization and environmental economics. Her research typically combines theory and data. Currently, her research focuses on carbon emissions markets, the design of electricity wholesale markets, and climate transition policies.

Ulrich Wagner, University of Mannheim

Ulrich J. Wagner is Professor of Economics at the University of Mannheim. His research interests are in environmental economics, industrial organization and public economics. Ulrich Wagner is a co-editor of the Journal of the Association of Environmental and Resource Economists, a co-editor of Economics: the E-Journal and an editorial board member of the Journal of Environmental Economics and Management. He is a co-winner of the 2015 Erik Kempe Award in Environmental and Resource Economics. Wagner received his doctoral degree in 2006 from Yale University and subsequently worked as a postdoctoral research fellow at the Earth Institute at Columbia University. Before joining the University of Mannheim in 2015, he worked as an Associate Professor of Economics at Universidad Carlos III in Madrid.

Matti Liski, Aalto University

Matti Liski holds a PhD in Economics from Aalto University. Currently, he is Professor of Economics at Aalto University School of Business. He is also an affiliate at MIT-CEEPR, University of Cambridge EPRG, CESifo Munich, and has been a visiting professor at Toulouse School of Economics. Liski is an award-winning teacher, with experience ranging from principles of economics and executive education to advanced international doctoral courses and summer schools on specialized topics. His research focus is both theoretical and empirical microeconomics with applications in industrial organization, public policy, energy markets, and climate change. Liski has given several keynote lectures in scientific conferences,



served as a board member in foundations and scientific associations, and has held several editorial duties in journals, such as the Scandinavian Journal of Economics. His research has appeared in journals such as Journal of European Economic Association, Economic Journal, Journal of Economic Theory, Journal of Public Economics, and Journal of Environmental Economics and Management.

Stefan Ambec, Toulouse School of Economics

Stefan Ambec holds a PhD in Economics from the University of Montreal. Currently, he is INRAE Research Professor at Toulouse School of Economics where he leads the TSE Energy and Climate Center. He is Editor-in-Chief for Resource and Energy Economics. His research focuses on the impacts of environmental policies: about their efficiency, fairness properties, their effect on firms' strategies, on the welfare of citizens and their behavior. Topics include the energy transition, water use, air quality and climate change.

Giulio Federico, European Commission

Giulio Federico holds a PhD in Economics from the University of Oxford. Currently, he is Head of the Unit at the Chief Economist Team (CET) of DG Competition, European Commission. As part of his role, he has overseen the work of the CET on numerous mergers and antitrust matters. Prior to joining DG Competition in late 2011 he worked in economic consultancy for 10 years and was a Vice President at Charles River Associates. He is an external faculty member at the Barcelona Graduate School of Economics, where he has taught on the Master in Competition and Market Regulation, and on the Executive Courses on Abuse of Dominance, Mergers and Energy.
